Current UAB or USA Residents may enter the AOS 2018 Yelton Essay Competition. Papers will be presented at the AOS/MOS Annual Meeting, May 17-19, 2018 at the Grand Hotel Marriott Resort & Spa, Point Clear, Alabama.

1. All active orthopaedic residents at UAB and USA are eligible and invited to enter the competition.
2. All papers submitted must be received in the AOS office **by March 1, 2018**.
3. All papers submitted in the competition should have an orthopaedic faculty member as a co-author of the paper.
  - a. The resident's name should be listed first, as the presenter and author.
  - b. The faculty member's name should be listed next as co-author. The resident should be an integral part of the paper and not just a presenting author.
4. To enter the competition, please submit to AOS:
  - a. The Registration Application
  - b. The Complete Paper
  - c. A One-Page Abstract
  - d. AAOS Financial Disclosure Form
  - e. FDA Status Form

**Both of these forms must be completed by All Authors and Co-Authors in order to be listed in the Annual Meeting Program and/or to present a paper. Failure to do so will disqualify your paper(s).**

**Deadline, March 1, 2018.** The paper should be as generic as possible, omitting names of co-authors, academic programs and hospital affiliations on the paper. (These should be listed on the accompanying one-page abstract.) *This will allow the paper to be judged impartially by the AOS Essay Competition Committee.*

All completed submissions must be papers presenting original research. No book chapters, case reports, etc., will be accepted for the Yelton Essay Competition.
